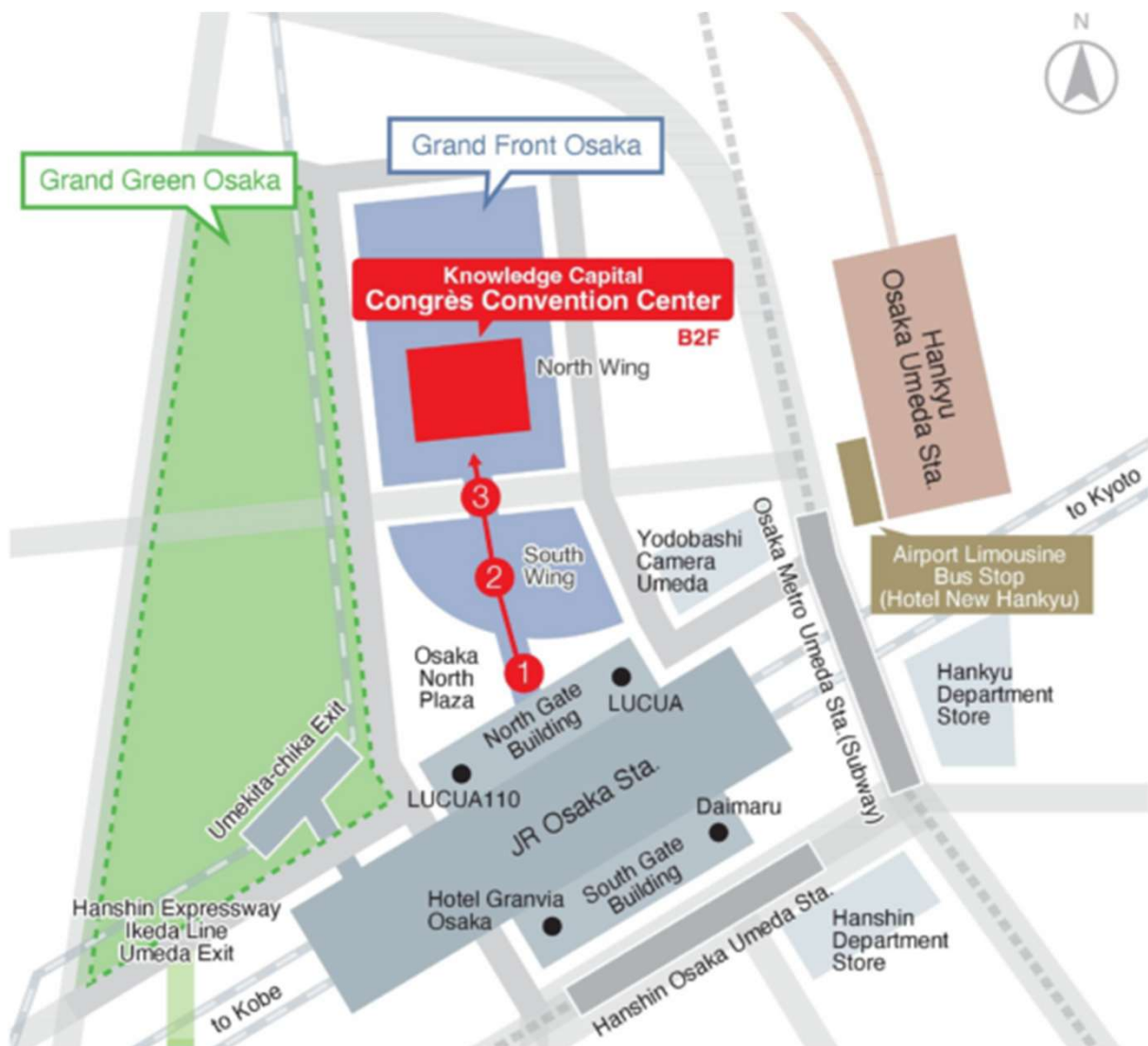

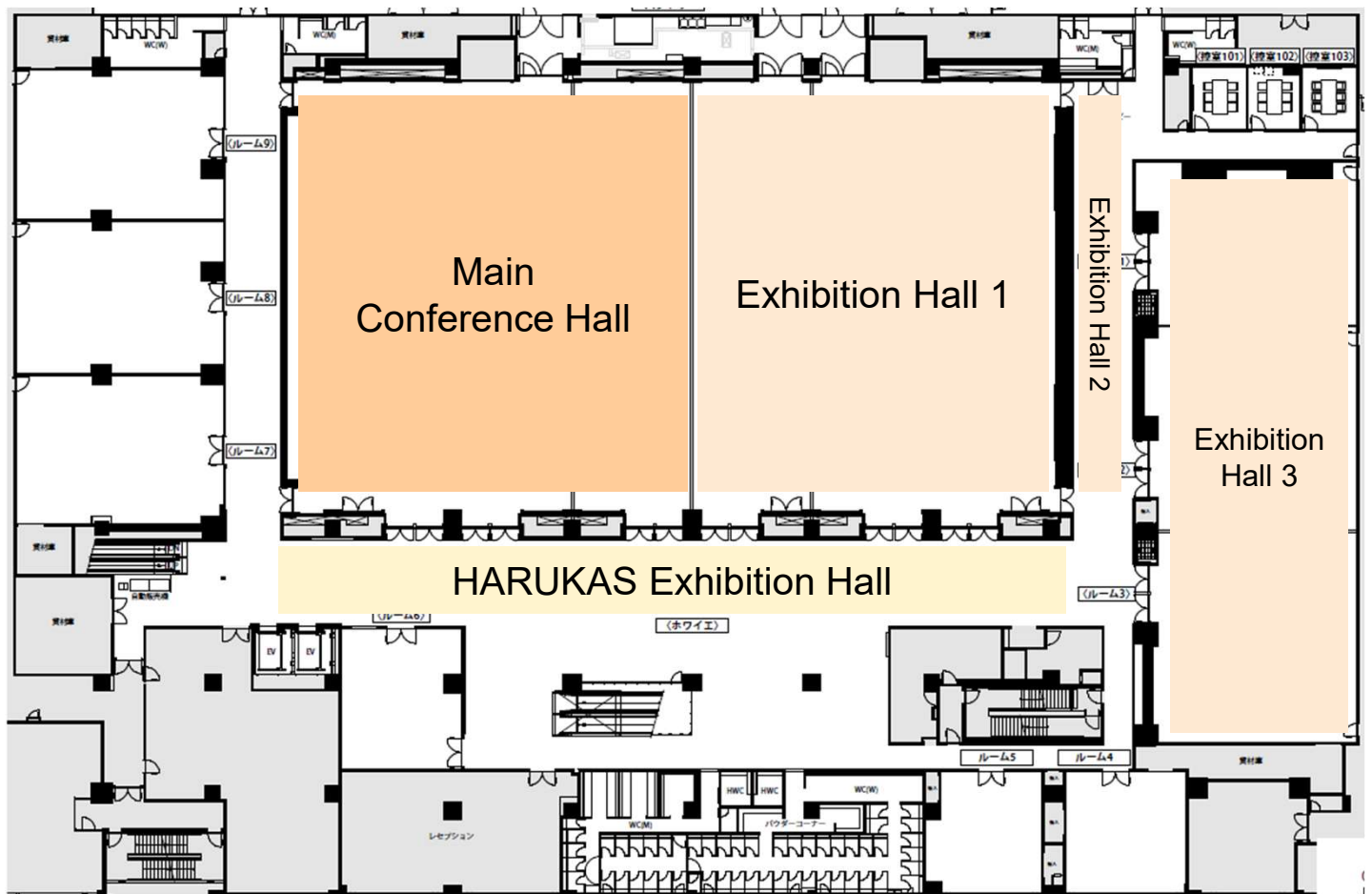

Hanshin “Osaka-Umeda” Station

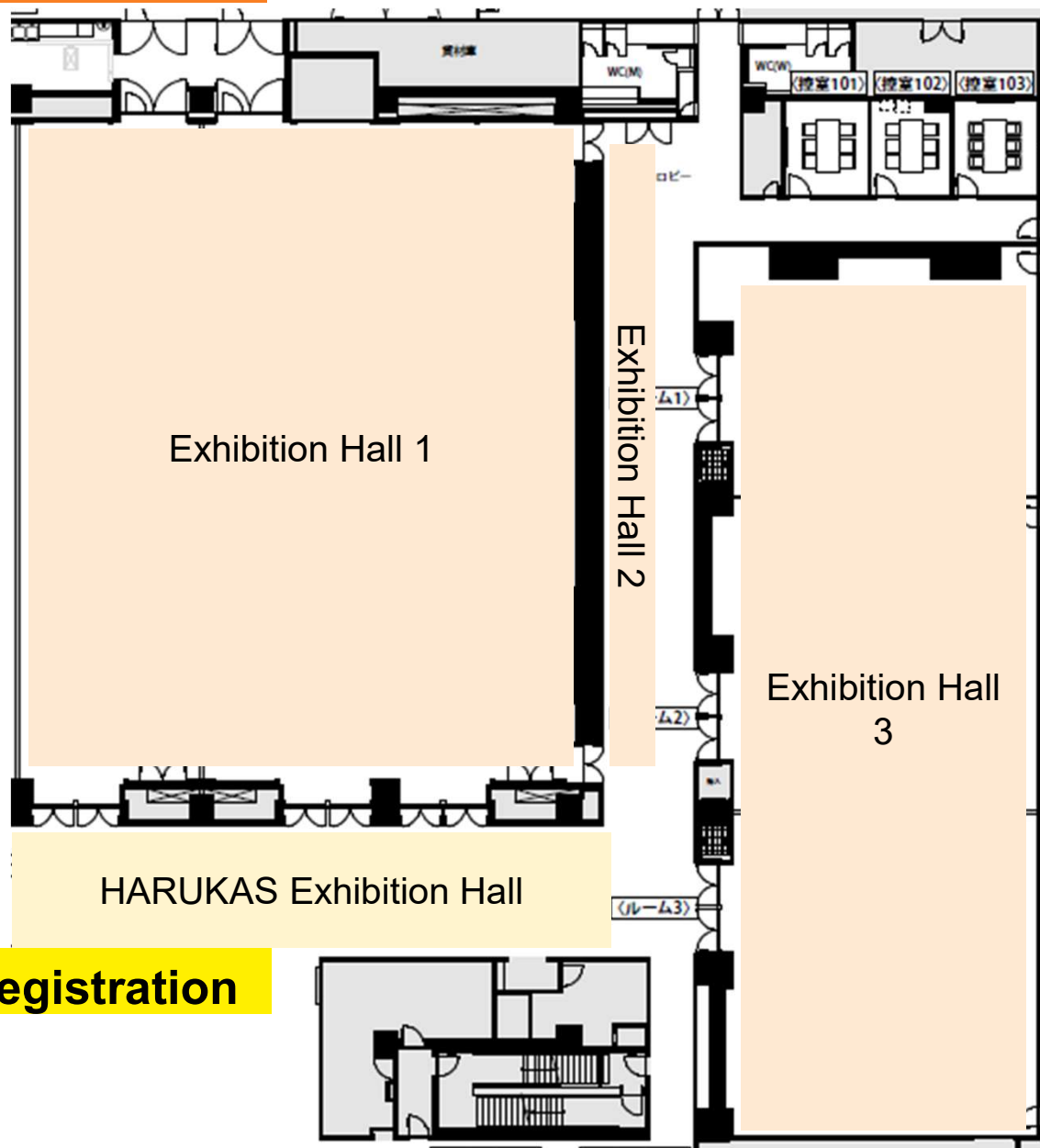

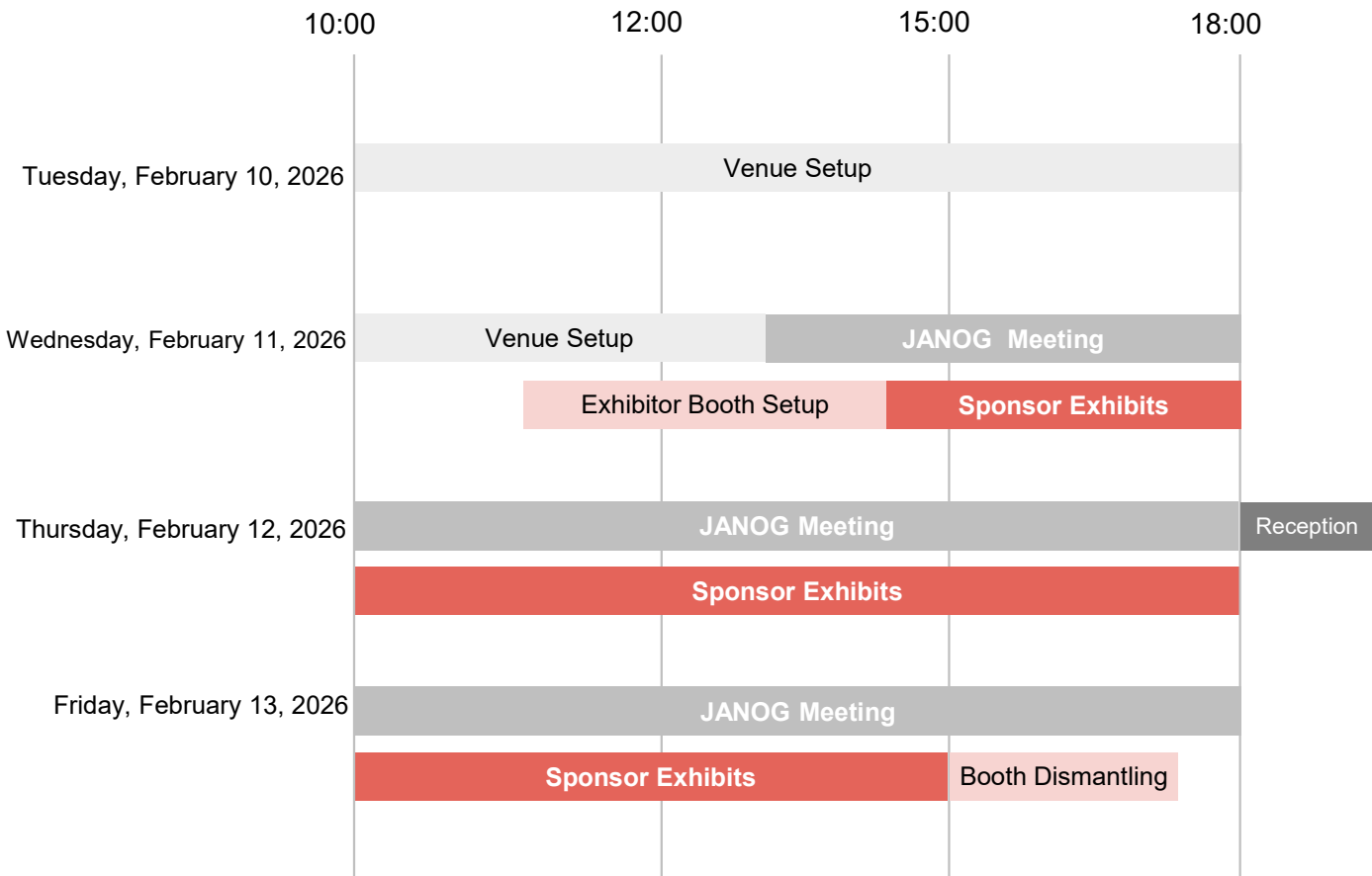

Contract Procedures

Sponsorship applications are accepted via a separately designated website.
The sponsorship agreement is concluded at the time your application is received.

Cancellation After Execution of the Sponsorship Agreement

If the sponsor cancels after the agreement is finalized, a cancellation fee will be charged according to the following terms:

Until November 7, 2025: 50% of the sponsorship fee (excluding tax)

After November 7, 2025: 100% of the sponsorship fee (excluding tax)

★If the sponsor decides to cancel the sponsorship or any optional services, a written cancellation form must be submitted.

Changes to or Cancellation of the Event

In the event of force majeure, such as natural disasters, epidemics, war, or any other causes beyond the organizer's control, where it becomes impossible to hold the event onsite, the organizer reserves the right to change the event format (including online events), change the dates or venue, or cancel the event entirely. In such cases, no refunds of sponsorship fees will be made.

If the event is canceled due to a state of emergency, event restriction orders, or requests from national or local governments in response to the spread of COVID-19, such a cancellation will be considered an act of force majeure.

If the event is held online only, this will not be considered a cancellation of the event. The organizer is not responsible for any damages or losses incurred by the sponsor due to changes in the event format, dates, venue, or cancellation of the event. If the organizer cancels the event due to its own reasons, it will refund the sponsorship fees after deducting necessary expenses incurred by the organizer. Beyond this, the organizer will not be liable for any other compensation.

Please review the above sponsorship and cancellation policy carefully. By checking the confirmation box on the application form, you agree to the terms outlined above. Your agreement will be considered confirmed upon completion of the application.
